



MEMORANDUM OF UNDERSTANDING

JAYSWAL NECO INDUSTRIES LTD. (JNIL), Siltara, Raipur



This Memorandum of Understanding (MOU) is made between

Vishwavidyalaya Engineering College, Lakhanpur-Ambikapur, A constituent college of Chhattisgarh Swami Vivekanand Technical University, Bhilai is a technical Institution funded by Government of Chhattisgarh is established in the year 2010 and incorporated in the CSVTU act 2004.

And

Jayswal Neco Industries Ltd. (JNIL), Steel Division, manufacturing unit at Siltara, Raipur established in the year 1996 hereafter called as JNIL

PURPOSE

The purpose of this MOU is to promote an integrated and collaborative strategic approach to product research, design, development, technology transfer and innovation which will benefit both organizations and serve as a model for industry- institute Linkage.

In doing so, the Parties will:

- Share market intelligence;
- Share non-confidential project information, evaluation and analysis.
- Participate in and jointly fund projects or programs.
- Leverage resources and involve other participants from governments, institute and industry.
- Undertake any other activities that reduce overlap and duplication and ensure a complementary approach to product research, design, development and innovation.
- Train VEC Lakhanpur students for handling projects.
- JNIL will depute working experienced (both technical and non-technical) personnas in imparting lecture, sharing of the knowledge at VEC Lakhanpur.

OBJECTIVES

The objective of this MOU is to build the framework for collaboration on product research, design, development, technology and innovation in accordance with the common goals of VEC Lakhanpur and JNIL including:

- To promote joint revenue generating activities in research, Testing, Calibration, consultancy and R&D etc. between the parties
- To facilitate joint research work in mining and steel making, involving faculty and students.
- To assess periodically the scientific and technological scenario/ happenings in India and abroad in order to translate it into action for faking up future R&D work.
- Providing opportunities for student groups to undertake problem-solving projects:
- Providing assistance to improve employability including entrepreneurial training, specialized skill training, and training in softer skills required by Industry.

DIRECTIONS

To meet the objectives of this MOU, the following strategic directions are envisaged:

1. Sharing funding for product research, design, development, innovation and academic activities to support the priority technology, opportunities and strengthen to the career of the VEC Lakhanpur.
2. Funding opportunities and engaging JNIL in collectively shaping a sustained agenda in product development and process modification.
3. Funding mission-oriented (fundamental, applied and demonstration) projects or programs that are supported by business plans upon mutual approval.
4. Building trust, creating synergies and a win-win approach that will benefit all participants.
5. Developing a portfolio approach for jointly managing private sector investments and working towards greater efficiency and effectiveness in intelligence gathering, proposal evaluation, proposal approval mechanisms, and project or program monitoring and knowledge disseminations.
6. Jointly engaging in public advocacy and external communications.

TYPES OF COOPERATION

- JNIL Confirms for providing knowledge and opportunities of product design, development process and cycle such as Designing, Assembling, Analysis, Tooling, Maintenance etc of components.
- In the account of Research Design and Development activities JNIL and VEC Lakhanpur shall be involved on Commercial Projects together, whereas projects shall be executed on basis.
- Explore the possibilities of assisting institution in establishing new laboratories, providing literature on new technologies, and offering their research and development section as substitutes for laboratories;
- Providing assistance for improving employability including entrepreneurial training, specialized skill training, and training in softer skills required by Industry.
- VEC Lakhanpur needs to encourage and enhance the activities to boost the country's economy through developing new knowledge innovations and technologies which can be adopted by Industries.

Mp

- The existing expertise available with VEC Lakhanpur can be utilized by the JNIL for technology assessment, up-gradation and absorption.
- VEC Lakhanpur and JNIL will jointly market all activities and when required also publish same in local news papers

In order to promote cooperation, latest technology, projects and advancement of academic, research and educational exchanges between VEC Lakhanpur and JNIL, the other scopes of MOU are as Follows:

1. VEC Lakhanpur can also provide training facility to employees of small scale and local industries and students of nearby engineering, polytechnic and ITI colleges.
2. Sharing best available case studies and technical study materials from both in VEC Lakhanpur and JNIL side once in quarter. The purpose of sharing the knowledge is to appraise each other about the developments, innovations, industry practices etc.
3. Faculty exchange (guest lecture) programs between VEC Lakhanpur and JNIL as per the suitability of topics
4. Development of new courses (PG certificate/diploma/degree) and inputs in syllabus setting mutually beneficial to both parties.
5. Advanced Training courses and industry oriented projects will be assigned to the meritorious students of Metallurgical, Mining and Mechanical Engineering.
6. Certificate: Joint certificate with both parties' logo will be issued to participants on successful completion of training at VEC Lakhanpur for the courses of Students and industrial participants.
7. Fee structure for training courses: The fee structure and revenue sharing model will be mutually decided for following categories for Basic and Advance:-
 - a) Students and faculties of VEC Lakhanpur.
 - b) Students and faculties from other institute.
 - c) Industry personnel

MODALITIES AND TENURE

The implementation of the provisions of the MoU will be monitored by a core Team comprising of designated team from JNIL and VEC Lakhanpur. MoU will come in to effect the date of signing by both JNIL and VEC Lakhanpur. MoU will be valid for 5 years. At the end of 5 years the committee will review the achievements and will extend on mutual agreement with any changes in the Scope of MoU.

The activities of the core team:

- a) To meet at least twice in a year
- b) To examine the activities already undertaken and/or completed
- c) To examine new proposals and activities



- d) To identify the resources-human, equipment and finance related

FINANCIAL AND PR ACTIVITIES

The parties shall not impose any financial obligations except for the products/software supplied. Both parties will share the revenues generated out of all the joint activities as mutually agreed upon-on case to case basis.

JOINT OWNERSHIP IN INTELLECTUAL PROPERTY RIGHTS

Both the parties here under agree that any invention made during joint research collaboration / project of JNIL and VEC Lakhanpur will have equal ownership in intellectual property rights. A detailed mutually agreed joint ownership agreement will be signed before filing any patent.

CONFIDENTIALITY

Both the parties here under agree that any information generated out of any of the provisions of the MoU should basically remain with them. This disclosure of any of such information could be given to a third party only with mutual concurrence of the two parties.

FORCE MAJEURE

Neither JNIL nor VEC Lakhanpur shall be liable to the other for any delay in or failure of their respective obligations under this MoU caused by occurrences beyond their control, including occurrences of fire, floods, Acts of God, acts of public enemies, wars, insurrections, riots, Strikes, lock-outs, sabotage act or regulation of the Government or any compliance therewith; and that either party shall promptly, but not later than seven days notify the other party of the commencement and cessation of such contingency and prove that such is beyond the control and affects the implementation of this Memorandum adversely; and further, that if such contingency continues beyond one month. Both parties agree to discuss and arrive upon an equitable solution for determination of the Memorandum, or otherwise decide the course of action to be adopted.

DISCLAIMER

Each Party will be solely responsible for its own acts and omissions (and the acts and omissions of its employees and other agents) and neither Party will have the authority nor will purport LO act for, or legally binding, the other Party in this project with a third party except as agreed in writing by the Parties.

AMENDMENTS OF MOU

No amendment(s) to this MoU shall be effective unless it is in writing and signed by duly authorized representatives of both the parties.

SETTLEMENT OF DISPUTES & JURISDICTION

In the event of any differences or disputes arising out of the interpretation or application of the provisions of this MoU, the parties shall immediately consult each other with the view to expeditiously resolve such differences or disputes in a spirit of mutual understanding and cooperation. This shall be first settled by discussion within the core committee. If that is not successful, it should be done by arbitration in accordance with the provisions of arbitration and conciliation act 1966 and the award made in pursuance thereof shall be binding.

All legal disputes shall be subject to the jurisdiction of the courts in Raipur


SEAL OF PARTIES


